

CPAC Meeting Minutes
September 11, 2025

Roll call: Eric Stender, Marilyn Stout, Tyler Wenger, Dominic Valenti, Grace Irvin (online), Addi Lemme, Olivia Bitner, Morgan Peterson, Nancy Robertson and Pam Johnson.

Eric called the meeting to order and asked for a motion to accept the minutes from the August meeting. Nancy moved to accept them. Pam seconded. Motion carried.

Treasurer's report: The treasurer's report showed a balance of \$12,750.81. Marilyn moved to accept the report. Nancy seconded. Motion carried.

Old business:

C3 mentoring is off to a good start.

The Drug Free committee met to build the 12 sectors and discuss who should fill the roles.

Notes from the meeting and a handout have been emailed.

New business:

Chestnut- Youth Prevention education is underway for 6th and 7th graders.

Alcohol campaign- Information cards for parents of 6th-12th graders will be mailed in October.

This is the year for IYS (8th,10th, 12th grades). Schools have from January until the end of the school year to participate in the survey.

Rx drug takeback is on October 25th.

Youth Advisory Committee (YAC) will be starting for the middle school students.

Chestnut has printed name tags for C3 mentoring.

Student leaders- Olivia will take charge of the popcorn stickers. Morgan will help.

Red Ribbon Week- Plans are still being made. Chestnut will reach out to student council to participate. Some activities will be psa's, chalk messaging, and tying ribbons around trees and car antennas. They will encourage the middle schoolers to participate. National Red Ribbon Week is October 23rd-31st.

Trunk or Treat is on October 25th, 2:30-4 PM. CPAC will have a table with bags to distribute.

Nancy suggested preparing 200 bags. Nancy, Betty and Pam will take care of this. Student leaders are invited to help.

Eric asked about the student perspective on vaping. The students said they had not seen anyone vaping or heard about anyone vaping.

Drug Free Committee- More definition is needed on the 12 sectors of participation. It was also suggested that CPAC network to partner with an event. At the next meeting, specific people need to be identified and who will approach these people to ask for their participation.

Chestnut will encourage schools to take the IYS early so that current data can be used for the grant application. The results usually come in around 6 weeks after the survey is completed.

C3 Mentoring planning- Day 2 will be presented in advisories with Laura Angotti presenting.

Eric asked Chestnut about using the 9 square to encourage other schools in the county to participate is the IYS. Grace said other incentives are in place. The 9 square idea can be developed at a later date or perhaps at the school carnival or field day.

Closing discussion:

C3 mentoring- The response to using the new room is positive. Tables can be arranged differently for different needs.

There was discussion about how to include character traits and to make sure there is time for discussion. The consensus was that mentoring is off to a good start and tweaks will be made. Eric asked Grace about the grant stipulation that grant money can't be used for food. Grace said that the grant money can be used for events, but food costs would come from CPAC. Grocery stores sometimes donate food for an event.
